DEPENDABLE

Third party independent controls with lot to lot consistency tested over multiple sites, instruments, operators, and cartridge lots



NON-INFECTIOUS

Do not contain any biological material of human or animal origin, precautions are not required when handling the products



EFFICIENT

Full process DNA and/or RNA controls that mimic patient sample to monitor analytical performance of the extraction, amplification and detection steps

Routine use of quality controls can assist in identifying shifts, trends, and increased frequency of random errors caused by variations in the test system, such as failing reagents or malfunctioning equipment. Early investigation can prevent failed assay runs.
